Course objective

Acquiring basic knowledge and elementary skills in organizing psychological help in difficult / crisis situations.

Course-related learning outcomes

- The student knows the issues of public health, insurance systems, in connection with the issues of psychological security P7S_WG_04

Methods for verifying learning outcomes and assessment criteria

Learning outcomes presented above are verified as follows:

forming assessment:

- knowledge is verified by short tests after the fourth and sixth teaching unit - short test + problem task;

- social skills and competences are verified by issuing partial grades resulting from: teamwork; rewarding activity; independent problem solving.



Summative rating:

knowledge is verified by a written test on the basic concepts of the organization of psychological assistance; passing threshold - 50% + 1;

exercises - average of partial grades.

Programme content

1. Psychological help as one of the basic links in the public security system. Personal and social security. Security threats to the individual. 2. Prosocial and anti-social behavior. Cognitive model of helping developed by Latany and Darley. 3. Crisis intervention - providing material, information and emotional support. A model of seven steps in crisis intervention. Tasks of Crisis Intervention Centers. 4. Selected social pathologies - the escalation of occupational stress and related consequences: mobbing, discrimination, harassment, burnout, workaholism. Violence in the family. PTSD - Post-traumatic stress disorder. 5. First Psychological Help. Basic principles, methods and techniques in psychologically difficult situations. Transmission of adverse information
