Purpose of the course

- 1. developing the skill to observe the reality and its transposition to a flat surface with the use of painting means of expression
- 2. learning basic rules of colour theory and the rules of colours blending in painting
- 3. learning the basic painting techniques
- 4. acquiring the skills of creative use of painting means of expression in the execution of a painting composition

Curriculum contents

Painting/ drawing study of nature - "Still life" - a cycle of works in the form of a painting/ drawing record based on the observed spatial situation

- use of a blob with a wide sweeping movement, taking into account the arrangement composition of the painting on a flat surface
- solving colour problems resulting from the observed spatial situation
- taking into account colour relations between objects with the application of colour theory and the principles of colours blending
- use of different painting tools (brush, spatula) and different paint application techniques (impasto, glaze)

A cycle of works being an authorial artistic response to the set subject - slogan

- compositions consisting in the change of climate, mood and nature of the space, including the changes of light, weather conditions, times of day, times of year, subjective mood of the observer
- the subject must be individually interpreted and the means of artistic expression must be properly adjusted

free technique - all drawing, painting techniques and their derivatives - collage, frottage, monotyping etc.

Teaching methods

- 1. Laboratory/ observation/ analysis/ interpretation/ a series of repetitions/ study of nature/ a cycle of works in the form of a painting/ drawing record based on the observed spatial situation.
