#### **Prerequisites**

The student has basic knowledge on the branches of law obtained in the first-cycle studies; applies basic legal concepts to analyze and understand legal phenomena; is aware of the role of law in shaping social structures and institutions.

## **Course objective**

Acquiring knowledge and skills essential for conducting business activity.

## Course-related learning outcomes

Knowledge:

The student analyzes in detail the procedural and substantive legal norms governing business and demonstrates their application in the practice of business management [P7S\_WG\_03]. The student evaluates the complexity of business regulations and their application in the context of legal risk management and business compliance [P7S\_WG\_08]. The student evaluates the methods of legal analysis processory to protect intellectual property and

The student explains the methods of legal analysis necessary to protect intellectual property and manage a portfolio of copyrights in a business environment [P7S\_WK\_02].

Skills:

The student applies legal knowledge to analyze and evaluate organizational and legal forms of enterprises and predicts legal consequences of management decisions [P7S\_UW\_01]. The student evaluates the legal consequences of business activities, including negotiation of contracts, creation of legal protection strategies and interpretation of legal regulations affecting the activities of enterprises [P7S\_UW\_06].

The student conducts a deep analysis of the legal aspects of social phenomena, especially those affecting business activities and organizational structures of enterprises, formulating reasoned legal opinions and developing research hypotheses on the impact of legal regulations [P7S\_UW\_07]. The student applies the knowledge of contract and property law in the context of corporate financial management, including in the field of debt security [P7S\_UU\_01].

Social competences:

The student develops the ability to analyze and integrate various legal aspects of business activities, enabling the creation of effective legal and management strategies [P7S\_KK\_01]. The student is prepared to make ethical decisions and actions in the field of business law, taking into account both legal regulations and higher ethical standards and corporate social responsibility [P7S\_KR\_01].

## Methods for verifying learning outcomes and assessment criteria

Learning outcomes presented above are verified as follows:

Formative assessment: discussions summarizing particular lectures and tutorials, solving legal problems during the classes that offers the opportunity to assess the student's understanding of the issues raised. Summative assessment: the knowledge acquired in tutorials is verified in a written test carried out in the last class. The knowledge acquired in lectures is verified in an exam. The exam has a written form and consists of open and multiple-choice questions.

# Programme content

The program includes information on the legal aspects of running a business, among other thingsorganizational and legal forms of entrepreneurs.

## **Course topics**

Lectures:

Economic activity - the concept, rules for establishing and running economic activity. The concept of an entrepreneur and a consumer. Organisational and legal forms of entrepreneurs. Self-employment. Civil law partnership. Commercial partnerships and capital companies. Procuration. National Court Register. Tutorials:

Performing legal actions: their forms, consequences of the non-observance of the forms' requirements. Preliminary contract.

Pledge (ordinary and registered) as security for the performance of the contract.

Compensatory liability (tort nad contractual liability) and its premises

Creditor protection in case of the debtor's insolvency.

## **Teaching methods**

informative, problem-based, conversational lecture using a multimedia presentation case studies, panel discussion
