## **Prerequisites**

The student should understand the importance of legal and institutional regulatory mechanisms in social life and in the economy. The student is aware of the role of law in shaping social structures and institutions as well as can assertively express their opinions and argue their position.

## Course objective

The aim of the course is to acquire knowledge and skills in the field of economic law by participants. Students learn about the most important areas of economic law, basic institutions and legal regulations in the field of economic law. Students will acquire skills related to the selection of an appropriate legal form for business ventures.

# Course-related learning outcomes

### Knowledge:

1. Student explains the concept and specific features of economic law.

- 2. The student lists and characterizes entities that can conduct business activity in Poland.
- 3. The student describes the rules of competition and consumer protection.

#### Skills:

- 1. The student is able to choose the appropriate legal form of running a business depending on its nature.
- 2. The student is able to solve practical legal problems in the context of regulated economic activity.
- 3. The student is able to prepare basic economic contracts.

### Social competences:

- 1. The student is aware of the responsibility for decisions made regarding the subject matter of the subject.
- 2. The student is prepared to think and act in an entrepreneurial way.
- 3. The student is aware of the need to maintain ethical standards resulting from the social role of a technical university graduate.

# Methods for verifying learning outcomes and assessment criteria

Learning outcomes presented above are verified as follows:

Formative assessment: discussions summarizing particular lectures, solving legal problems during the classes that offers the opportunity to assess the student's understanding of the issues raised. Summative assessment: a written test which consists of closed and open questions.

## Programme content

The concept of the economy, the functions of the law in the economy, state interventionism, the Polish Constitution on the economy.

- 1 Concept and characteristics of economic activity, exclusion.
- 2 Entrepreneur, concept, categories, forms of business support.
- 3 Foreign entities in the economy, groups of entities, forms of business, branches and representations, other foreign enterprises.
- 4 Rules for taking up business, National Court Register and Business Register, CEIDG.
- 5 Principles of economic activity: the principle of freedom, equality, fair competition and the prohibition of anti-competitive practices.
- 6 Administrative tools for state intervention in the economy and administrative and economic regulation, objectives and means of regulation.
- 7 Business concession, characteristics, authorities, proceedings, tendering, control.
- 8 Permits, licenses and business consents.
- 9 Control and supervision of the trader.
- 10 Administrative inspections, State Sanitary Inspection, Trade Inspection, State Labour Inspectorate.
- 11 Administrative guards, municipal guards, technical supervision.
- 12 Economic activities of local authorities, the municipality's own tasks, public service activities and its characteristics.
- 13 Legal and organisational forms of municipal enterprises.
- 14 Public-legal partnership, concept, legal basis, rules and procedures, entities, contract, supervision.
- 15 Economic self-government and chambers of industry in Poland.
- 16 Natural person, concept, legal capacity and legal capacity.
- 17 Legal person, concept, division, types, authorities, legal capacity and capacity. 18 Conclusion of the contract in civil law.
- 19 Form of legal acts.
- 20 Representation and power of attorney in civil law.
- 21 Limitation of claims under civil law.
- 22 Cooperative law, establishment of cooperatives, members, their rights and obligations, bodies, bankruptcy and liquidation, cooperative associations.
- 23 Economic activities of foundations and associations in Poland, activities for 20 years and free of charge, economic activities of NGOs.

- 11. Simple joint stock company, formation of a company, articles of association, legal personality, shareholders, organs of the company, assets.
- 12. Public limited liability company: limited liability company: formation of a company, partnership agreement, legal personality, shareholders, organs of the company, assets.
- 13. Public-private partnership, concept, characteristics, scope, contract, control, risk.

## **Course topics**

The concept and principles of economic activity. Freedom to undertake and conduct business activity in the national law and European Union law as well as its limitations (concessions, permits, regulated business activity). Organizational and legal forms of enterprises. A natural person as an entrepreneur. Civil law partnership. Commercial partnerships and capital companies - characteristics, formation, responsibility for the company's obligations, running the company's affairs and its representation. Entrepreneurs' registers: Central Register and Information on Economic Activity - CEIDG and National Court Register - KRS. Matrimonial property regimes. Proxy as a special type of power of attorney granted by an entrepreneur. Economic contracts. Labour contract versus civil law contracts (contract of mandate, contract of specific work). Competition and consumer protection.
