Prerequisites

Student has knowledge of the foundations of management delivered at the first-level studies. In addition, he should also be able to use the acquired knowledge in practice and he is ready to work within team structures.

Course objective

The aim of the course is to provide students with knowledge about the functioning of modern enterprises of various sizes including structural solutions. In addition, the student learns selected management concepts used in modern enterprise, also in the aspect of sustainable development.

Course-related learning outcomes

Knowledge:

- 1. Student has in-depth knowledge of company functioning and management as well as its connections with the logistics area, [P7S WG 01], [P7S WG 05]
- 2. Student has extended knowledge of management processes implemented in the field of logistics and supply chain management, [P7S_WG_08]
- 3. Student has in-depth knowledge of enterprise management methods, tools and techniques applicable

in the area of logistics, [P7S WK 01]

4. Student has basic knowledge about the life cycle of socio-technical systems in the field of logistics management, including principles regarding the scope of protection of industrial property and copyright as well as the law regulating logistics, [P7S WG 06], [P7S WK 05]

Methods for verifying learning outcomes and assessment criteria

Learning outcomes presented above are verified as follows:

Lecture: Knowledge acquired during the lecture is verified by short tests carried out after 2,4,6 lecture. The tests consist of 8 closed questions (4 for each lecture). Assessment threshold: 50% of the points (satisfactory).

Tutorials: The knowledge acquired in the exercises is verified on the basis of solving individual tasks included in the course program. For each task the student receives points. Assessment threshold: 50% of the points (satisfactory).

Programme content

The programme covers a range of business management issues (including: organisational structures, processes, resources).

Course topics

Lecture: Organization as a socio-technical system and its goals (including: management concepts in organizations, enterprise management system and process), Creating market advantage (cost, differential, specialization and diversification of enterprise development paths). Business management paradigms in an economy based on a smart and sustainable development. Enterprise management system, structures and conditions. Divisions and services in the enterprise. Typical business processes

Teaching methods

Lecture: Information lecture in the form of a multimedia presentation, with elements of a conversational lecture.

Tutorials: Solving project tasks based on the case study method.
