## **Prerequisites**

When starting this course, the student should have basic knowledge of the economics and organization of transport and should know the principles of operation of a transport company. He should also have the ability to obtain information from the indicated sources and be ready to cooperate as part of the team.

# Course objective

The aim of the course is to provide students with basic knowledge of civil law in business transactions. During the course, students will get acquainted with: exemplary contract templates applicable in business transactions in relation to transport and forwarding, legal conditions for conducting negotiations and pursuing claims.

## Course-related learning outcomes

## Knowledge:

- 1. Student knows the provisions of civil law in relation to transport and forwarding and their connection with logistics [P7S WG 01]
- 2. Student knows the extended terms for shipping and transport and detailed issues in these areas, including the application of civil law to the logistics supply chain management [P7S WG 05]

3. Student knows the conditions of the functioning of transport and forwarding companies as participants of logistic processes and the strategies of their functioning [P7S WK 02]

#### Skills:

- 1. Student is able to gather, based on the literature on the subject and other sources (in Polish and English) and in an orderly manner, present information on the problem falling within the scope of the application of civil law in transport and forwarding and logistics supply chain management [P7S UW 01]
- 2. Student is able to communicate using properly selected means from civil law in the professional environment and in other environments within the scope of transport and forwarding and in the logistics supply chain management [P7S UW 02]
- 3. Student is able to identify changes in requirements, standards, regulations, technical progress and the reality of the labor market, and on their basis determine the need to supplement his own and other knowledge [P7S\_UU\_01]

- 1. Student notices the cause-and-effect relationships in the implementation of the set goals and grading the significance of alternative or competitive tasks in the application of civil law [P7S KK 01]

# Methods for verifying learning outcomes and assessment criteria

Learning outcomes presented above are verified as follows:

Lecture: The knowledge acquired in the scope of the lecture is verified on the basis of a final test in the form of a test consisting of 25 closed multiple-choice questions. Completion of the lecture after obtaining a minimum of 60% of points.

Exercises: Credit based on the result of the final test in the form of a test with multiple-choice closed questions - 25 questions - after obtaining a minimum of 60% of points and active participation in classes

# Programme content

The program content includes knowledge of civil law in relation to road transport of goods and passengers

## **Course topics**

Lecture: Contracts and obligations in business transactions. The essence of the contract. Agreements on the transfer of rights. Contracts for the use of someone else's things or rights. Service Agreements. Contract of carriage. Types of contracts most often concluded in road transport and the resulting rights and obligations. Regulations and obligations arising from the Convention on the Contract for the International Carriage of Goods by Road (CGR). Negotiations. Negotiating legally binding transport contracts, especially with regard to the conditions of carriage. The essence of the claim. Pursuing claims. Limitation of claims. Consideration of the principal's claim for compensation for loss or damage to goods during transport or for delay in delivery and identifying how the claim affects his contractual liability. Investigating a principal's claim for compensation for passenger injuries or damage to baggage caused by an accident in transit or for compensation for delays and identifying how the claim(s) impacts his contractual liability. The carrier's liability for non-performance or improper performance of the passenger/cargo transport contract.

Exercises: Best practices and case studies in the field of civil law (case studies).

## **Teaching methods**

Lecture: an informative lecture supported by a multimedia presentation illustrated with examples. Exercises: exercise method supported by a multimedia presentation illustrated with examples and performing tasks given by the teacher - practical exercises (solving case studies). Local education methods on the ekursy.put.poznan.pl platform.
