

Ordinance No. 13
of the Rector of Poznan University of Technology
of 13 May 2024
(RO/V/13/2024)

regarding fees for accomodation in Poznan University of Technology dormitories

Acting pursuant to article 79 section 2 point 6, and article 23 section 2 point 2 of the Act of July 20, 2018 - Law on Higher Education and Science (Journal of Laws of 2023, item 742), I hereby establish the following:

§1

1. The price list below shall apply only to students and PhD students staying in student rooms for a period longer than 1 month.
2. The monthly (gross) fee for one spot in the dormitories of the Poznan University of Technology shall be:

c) in a 2-person room (with a bathroom for 4 rooms)	670	810
d) in a 3-person room (with a bathroom for 4 rooms)	605	765
5. in Dormitory No. 6		
a) in a 1-person room (with a bathroom for 2 rooms)	875	1075
b) in a 2-person room (with a bathroom for 2 rooms)	700	860
c) in a 3-person room (with a bathroom for 2 rooms)	635	780

3. If the accommodation period does not cover a full month, the fee shall be charged at a daily rate of 1/15 of the monthly fee (the amount is rounded to the nearest whole zloty). In such a situation, the fee may not exceed the amount specified in section 2.

4. The gross fee for a spot in the Poznan University of Technology dormitories for people with a certificate of disability shall be reduced and, rounded to the nearest whole zloty:
 - a) for persons with a certificate of severe disability, 60% of the fee;
 - b) for persons with a moderate degree of disability, 70% of the fee;
 - c) for persons with a certificate of mild disability, 80% of the fee.

5. Payment for accommodation that starts after the 15th of the month must be paid no later than on the day of commencement of accommodation. For the following months, residents shall pay fees by transfer by the 15th day of a given month. After exceeding this deadline, statutory interest shall be charged for each day of delay.

6. In the event of vacancies and at the request of a resident/residents who want to stay in a dormitory room with partial occupancy, the fee may be reduced by 50% for each vacant place.

§2

1. Residents of dormitories accommodated pursuant to this ordinance shall pay a deposit in the amount equivalent to a monthly fee. The deposit is a means of covering any damage caused by the resident in the dormitory or student housing complex.

2. The deposit shall be paid by transfer, immediately, in the first month of accommodation.

3. The deposit or its part shall be returned within 14 calendar days after the end of residence in the dormitory, in a form agreed upon with the manager of the dormitory (cash, bank transfer).

§3

1. Persons signing conditional contracts shall pay a reservation fee of PLN 300 within 5 days after signing it. Failure to pay the reservation fee will result in the contract being considered invalid.

2. The reservation fee is, after accommodation, part of the accommodation fee due.

3. Resignation from accommodation, despite a prior reservation, shall result in a forfeiture of the reservation fee to the Poznan University of Technology.

§4

1. To the extent possible, the manager of a dormitory may, at the resident's request, agree to store his or her belongings in a depository for a fee of 50% of the rate specified in §1 section 2 and 3. If remote learning is introduced due to force majeure, the student shall have the option of using the depository for a fee of PLN 150 for each started month.

2. Poznan University of Technology is not responsible for items left in the depository.

§5

1. Additional fees (penalties) are as follows:
 - a) for causing an unjustified arrival of the fire brigade - PLN 500.
 - b) for losing the Guest Card - PLN 60
 - c) for losing the room key - PLN 60

§6

1. The Chancellor determines the amount of fees:
 - a) for guest rooms located in Dormitories No. 1-6;
 - b) in cases not regulated by § 1.

§7

1. Ordinance No. 22 of the Rector of the Poznan University of Technology of June 12, 2023 (RO/V/22/2023) on fees for rooms in Poznan University of Technology dormitories is hereby repealed.

§8

The ordinance enters into force on the day of its signing, with effect from 1 October, 2024.
